### About the Legal Aid Justice Center

LAJC is a nationally recognized anti-poverty nonprofit committed to battling poverty and injustice through individual legal representation, group and class action litigation, community organizing, policy advocacy, and media relations. From its offices in Charlottesville, Richmond, Petersburg and Falls Church, LAJC is a fierce advocate for low-income clients and communities in Central and Northern Virginia, and its work broadly impacts the entire state. Just in the past year, our team of attorneys and organizers won a class-wide injunction ordering healthcare reforms in a women's prison, persuaded Virginia to enact the first COVID-19 specific workplace safety standards in the nation, worked successfully in partnership with community leaders to demand police accountability, and won major legislative reforms regulating school policing.

Founded in 1967, LAJC provides services under four key program areas: Civil Rights & Racial Justice, Economic Justice, Youth Justice, and Immigrant Advocacy. LAJC boldly tackles issues of systemic injustice and aims to raise public and policymaker awareness of some of the most pressing challenges facing low-income Virginia residents. # About the Position

We are looking for a full-time team player willing to jump right into our bustling Affordable Care Act (ACA) open enrollment sign up season November 1-December 15, and then to undertake additional outreach and organizing responsibilities year-round. We have managed a robust ACA navigation program active since 2013. Our experienced Navigators will assist in training our new recruit, and will provide remote support. This position is based out of our Falls Church office, which primarily serves low-income immigrant communities in Northern Virginia. Outside of the open enrollment period, job duties will include answering questions and enrolling eligible people in the ACA through special enrollment as needed, while also performing outreach to and organizing with local communities regarding public benefits or other issues, and assisting other LAJC community organizers in various organizing campaigns.

Note: LAJC is currently working remotely, and we are eager to provide a welcoming virtual environment for all who apply. We will provide flexibility for the applicant hired for this position to work remotely for at least the first six months after their start date. However, for this position a small amount of in-office work (with appropriate health and safety precautions) may be necessary in order to collect and scan documents from clients. If you have any questions or concerns about this, we are happy to discuss these requirements with you.

#### Responsibilities include:

- Engaging in outreach and education around ACA and other benefits
- Enrolling eligible individuals in ACA insurance and other benefits programs
- Working with our team of attorneys and organizers to build strength, support, and trust in local client communities.

### Required Qualifications

- Strong commitment to social, economic, and racial justice
- Demonstrated experience working with individuals and/or communities directly impacted by economic and racial injustice
- A high level of professionalism and outstanding interpersonal communication skills
- Ability to work effectively both independently and collaboratively
- After hiring, the candidate must meet all state and federal requirements to qualify as an ACA navigator to ensure continued employment
- Reliable transportation
- Fluent in Spanish
